

## John Daly Soccer Camps Participant Agreement

In consideration of my acceptance to engage in the John Daly Camp on (date of Camp)\_\_\_\_\_,2017 at The College of William & Mary, I do hereby release William & Mary Sports Camps and Clinics and The College of William & Mary, its officers, directors, employees, and agents ("the College") from responsibility for:

- a. Any and all injuries caused by the negligence, recklessness, or intentional acts of myself and/or any third parties. My waiver of personal injury does not include injury caused by the negligence, recklessness, or intentional acts of the College.
- b. Any and all property damage that may occur while I participate in the John Daly Soccer camps. My property damage waiver includes all property damage, including that caused by the negligence, recklessness, or intentional acts of myself, third parties, and/or the College.

I hereby acknowledge that my (or my child's) participation is strictly voluntary, and that by signing this document I knowingly assume all risks associated with my (or my child's) participation in the John Daly Soccer camps. I agree to stop and request assistance if I (or my child) experience any symptoms such as, but not limited to, dizziness, excessive fatigue, dehydration, shortness of breath, pain, or any other conditions which would make it difficult or unsafe to continue. I (or my child) further agree to obey all federal, state, and local laws, use proper safety equipment, and follow the instructions of the John Daly Soccer camps sponsors and representatives while participating in this event. I attest that, to my knowledge, my (or my child's) [LIST REQUIRED ATHLETIC EQUIPMENT THAT CAMPER MUST PROVIDE] and related equipment are in proper working order.

**Assumption of Risk:** I fully appreciate the nature and extent of the risks involved in Soccer. Participation in an athletic event carries with it certain inherent risks that cannot be eliminated regardless of the care taken. These risks include, but are not limited to:

- Collisions with another athlete or spectator
- Cuts, scrapes, bruises, concussions, loss of consciousness, and musculoskeletal injuries
- Falling and tripping
- Failure of other athletes or of spectators to observe proper safety procedures or heed safety instructions
- Unanticipated equipment failure or malfunction
- Injuries and illness resulting from the effects of weather, including high heat or cold temperatures, high winds, sun exposure, humidity, and precipitation
- The effects of uneven or wet playing surfaces and of gravel or debris present on the playing surface

**Representations Concerning Health:** With full knowledge of the risks inherent to Soccer, I represent that I (or my child) am in good health and do not have any condition which will interfere with my (or my child's) ability to participate in the John Daly Soccer camps or endanger my (or my

child's) health in connection with the John Daly Soccer camps. I acknowledge valid and current insurance to cover any injury or damage I (or my child) may cause or suffer while participating in the John Daly Soccer camps or otherwise agree to personally bear the costs of such injury or damage. I authorize, but do not obligate, a John Daly Soccer camps representative to seek emergency medical treatment for me (or my child) in the event of an accident or illness that occurs during my (or my child's) participation in the John Daly Soccer camps, even in the event that I (or my child) am unconscious or otherwise cannot consent. I attest that if I (or my child) have recently suffered an illness, injury, or impairment, or have any concerns about my (or my child's) ability to participate in the John Daly Soccer camps, I should have or did consult a physician prior to my (or my child's) participation. I further take full responsibility for consulting a physician if I experience any doubt as to my (or my child's) ability to successfully and safely complete any John Daly Soccer camps activity once it has begun.

**Acknowledgement of Understanding:** I have read this agreement and fully understand its terms. **I acknowledge that I am signing the agreement freely and voluntarily, and intend it by my signature to be a release of liability as stated above and as it relates to the John Daly Soccer camps to the greatest extent allowed by law.** I further state that I am of lawful age and legally competent to sign this affirmation and release (or that I am lawfully signing it on behalf of a minor child), and that I have signed this document of my own free will.
