

**2025 MARIO CRISTOBAL CAMPS LLC.**  
**FORM MANDATORY WAIVER AND RELEASE**

IN CONSIDERATION of the undersigned participant ("Participant") being allowed to participate in the in the Ultimate Youth Camp (the "Event") to be held on May 21<sup>st</sup> & 28<sup>th</sup> 2025, at the University of Miami Practice facility, Coral Gables, Florida (the "Premises"), being hosted by Mario Cristobal Camps, LLC, ("MCC") a Florida limited liability company from 3:00p.m. to 8:00 p.m. (the "Event"), and understanding and acknowledging that MCC is a limited liability company which is receiving no monies or other monetary benefit for providing support for the Event and is expressly relying on this Waiver and Release in allowing Participant to participate in the Event, we, the Participant and the parent(s) and/or legal guardian(s) of the Participant, jointly and severally, and intending to legally bind ourselves and the Participant, and on behalf of our respective spouses, ex-spouses, grandparents, family members, guardians, heirs, executors, personal and legal representatives, estates, beneficiaries, administrators, successors and assigns (all of the foregoing collectively, the "Releasers"), do hereby waive, release and discharge, and covenant not to sue, the MCC, its sole member, the Event sponsors, grantors, Mario Cristobal LLC, University of Miami, officials, referees, and all of and their respective shareholders, trustees, officers, directors, employees, staff, volunteers, members, managers, agents, contractors and supervisors and their respective heirs, beneficiaries, executors, estates, legal and personal representatives, , and successors and assigns (all of the foregoing collectively, the "Releasees") from any and all liabilities and/or claims for illness, personal injuries, disability, death and/or damages that may arise directly or indirectly as a result of Participant's participation in the Event, including, without limitation, any rights, claims, causes of action, suits, liabilities, negligence, damages, personal or bodily injury, disability, death, property damage, loss of consortium, costs and expenses whatsoever, whether arising at law or in equity, and whether arising before, during or after the Event, and whether caused, in whole or in part, by the sole or joint negligence or tortious act or omission of the Releasees or any of them or any third party (collectively, the "Claims"). The Releasers, jointly and severally, hereby agree to indemnify and hold the Releasees harmless from all such Claims, including, without limitation, attorneys' fees. The Releasers acknowledge that the terms of this General Release are contractual and not a mere recital. The Releasers hereby knowingly and voluntarily waive, to the fullest extent permitted by law, the benefits of any statute, law, rule or common law which may limit the scope of the covenants and releases contained herein. The Releasers, and each of them, hereby agree that they will forever refrain and forbear from commencing, instituting or prosecuting any lawsuit, action or other proceeding of any kind whatsoever, by way of action, defense, set-off, cross-complaint, counterclaim or third-party action, against the Releasees, or any of them, based on, relating to, or arising out of, or in connection with any Claims. Releasers further acknowledge and agree that (i) despite all reasonable actions and precautions, until global widespread vaccinations are available nothing can prevent infection with the coronavirus known as COVID-19 virus; (ii) Claims expressly include those which may arise out of, or relate to, or in connection with, Participant's contraction of COVID-19 and that Releasers knowingly and willingly assume all risk with respect thereto. and (iii) AN INHERENT RISK OF EXPOSURE TO COVID-19 EXISTS IN ANY PUBLIC PLACE WHERE PEOPLE ARE PRESENT AND THAT COVID-19 IS AN EXTREMELY CONTAGIOUS DISEASE THAT CAN LEAD TO SEVERE ILLNESS AND DEATH. STAY-AT-HOME. By their execution below, the Releasees represent and warrant the following is true on the date of the Event: (a) within the prior 14 days, Participant has not tested positive for, or been exposed to, someone who has tested positive for, COVID-19 nor has any person with whom Participant has had close contact tested positive for, or been exposed to, someone who has tested positive for, COVID-19; (b) within the prior 48 hours, Participant has not (nor has any person with whom Participant has had close contact) experienced symptoms of COVID-19 (e.g., a fever of 100.4°F or higher, cough, shortness of breath/difficulty breathing, chills, repeated shaking, muscle pain/aches, headache, sore throat, loss of taste/smell, nasal congestion, runny nose, vomiting, diarrhea, fatigue or any other symptoms associated with COVID-19 as identified by the CDC); or within the prior 14 days, Participant has not (nor has any person with whom Participant has had close contact) traveled to any location identified by applicable governmental authorities as being subject to travel or quarantine advisories due to COVID-19.

In the event that this waiver and release is found to be invalid, unenforceable or void, in whole or in part, for any reason whatsoever, then the releasers acknowledge and agree that in no event, including, without limitation, the negligence, gross negligence or willful misconduct of the releasees, or any of them, shall the releasees' aggregate liability to releasers or any other person exceed \$300,000.00, and in no event shall releasees, or any of them be liable to any person for special, incidental, consequential or punitive damages or for any indirect damages such as, but not limited to, exemplary damages or lost earnings, lost revenues or loss of consortium or companionship (even if the releasees have been advised of the possibility of such damages), whether based upon statute, contract, tort, negligence, strict liability or otherwise.

The Releasers are aware of, and understand fully, the inherent risks involved in connection with football (meaning those dangers or conditions, known or unknown, which are characteristic of, intrinsic to, or an integral part of the activity and which are not eliminated even if the activity provider acts with due care in a reasonably prudent manner). The Releasers also fully understand that football is a violent sport that involve strenuous exertions of strength using various muscle groups, some involve quick movements involving speed and change of direction, some involve contact with equipment, other participants (including other participants that are older or younger and who may be larger or smaller (in terms of weight and height) than Participant), and various surfaces (which may be uneven), and other activities involve sustained physical activity which place stress on the cardiovascular system and stress to the body overall, and that serious injury, catastrophic injuries including paralysis, death and concussions have and do occur, and each of them assumes full, sole and complete responsibility for, and risks of, death, personal or bodily injury, disability and/or property damage resulting from, in connection with, or in any way related to, Participant's participation in the Event. The Releasers further acknowledge that medical staff will be present on site and consent to immediate medical attention if deemed necessary. The Releasers acknowledge that other participants, referees, officials, bystanders, members of the public and others may act irresponsibly, engage in unsafe conduct or to the detriment of the health and wellbeing of the Participant; that MCC is not the owner, operator or manager of the facilities or sites where the Event takes place and that there may be latent or patent defects in or around such facilities or sites over which the MCC has no control and shall have no responsibility for the conditions of the facilities or sites; that any of the foregoing could result in death or bodily injury to the Participant and the other risks and hazards described herein and, in each instance, the Releasers and each of them

voluntarily and knowingly assume such risks and waive, release and discharge, and covenant not to sue, the Releasees or any of them with respect to any Claims with respect thereto.

The Releasors further acknowledge and agree that the undersigned have and without compulsion or compensation or reliance on any representation of any kind whatsoever by the Releasees or others voluntarily decided to allow Participant to attend and participate in the Event and to assume full, sole and complete responsibility for, and risks of, death, bodily injury, property damage and the other risks and hazards described herein resulting from, in connection with, or in any way related to, the Participant's attendance and participation at the Event and to waive and release the Claims as provided herein. The Releasors, and each of them, hereby agree that they will forever refrain and forbear from commencing, instituting or prosecuting any lawsuit, action or other proceeding of any kind whatsoever, by way of action, defense, set-off, cross-complaint, counterclaim or third-party action, against the Releasees, or any of them, based on, relating to, or arising out of, or in connection with, any Claims. By their execution below, understanding that the Releasees are relying hereon in allowing Participant to participate in the Event, the Releasors hereby represent and warrant to the Releasees, that (i) all of Participant's living parents and/or legal guardian(s), as applicable, have duly signed this General Release and Waiver, and (ii) Participant has no medical condition (physical or mental) which would or could impact on the Releasees allowing Participant to participate in the Event and that the Participant is physically able to participate in the Event, and (iii) the Participant is not taking any herbal or medicinal supplement or prescription that could impact on Participant's participation in the Event.

Furthermore, the Releasors acknowledge that the Releasors have received the opportunity (and been strongly encouraged) to review this General Release and Waiver with an attorney in connection with the effect of the execution and delivery of this General Release and Waiver, that the Releasors have carefully read and fully understand the contents of this General Release and waiver in its entirety and have asked and received answers to all questions he/she/they may have, and that the Releasors have duly executed this General Release and Waiver freely and voluntarily, intending and agreeing to be fully bound by the terms hereof.

**NOTICE TO THE MINOR CHILD'S PARENTS/NATURAL GUARDIANS: READ THIS FORM COMPLETELY AND CAREFULLY. YOU ARE AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING THAT, EVEN IF RELEASORS USE REASONABLE CARE IN PROVIDING THIS ACTIVITY, THERE IS A CHANCE YOUR CHILD MAY BE SERIOUSLY INJURED OR KILLED BY PARTICIPATING IN THIS ACTIVITY BECAUSE THERE ARE CERTAIN DANGERS INHERENT IN THE ACTIVITY WHICH CANNOT BE AVOIDED OR ELIMINATED. BY SIGNING THIS FORM, YOU ARE GIVING UP YOUR CHILD'S RIGHT AND YOUR RIGHT TO RECOVER FROM RELEASEES IN A LAWSUIT FOR ANY PERSONAL INJURY, INCLUDING DEATH, TO YOUR CHILD OR ANY PROPERTY DAMAGE THAT RESULTS FROM THE RISKS THAT ARE A NATURAL PART OF THE ACTIVITY. YOU HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM, AND RELEASEES HAVE THE RIGHT TO REFUSE TO LET YOUR CHILD PARTICIPATE IF YOU DO NOT SIGN THIS FORM.**

Participant and Parents/Guardians consent to all recording and photographing ("Images") of Participant at the Event and hereby grant full consent to the MCC to the free use of the Participant's picture and/or name in any broadcast, telecast, print media or otherwise on account of or at the Event for any purpose whatsoever, including, without limitation, in promotional materials, without payment to Participant and without Participant's or Parent/Guardian's approval. Participant and Parents/Guardians further agree that MCC owns the copyright for all Images.
